1. Overview


In 2013, the Colorado State Legislature passed the Colorado Road and Community Safety Act (SB13-251). Under SB 251 all Colorado residents, no matter their immigration status, are eligible to apply for a Colorado license or state ID if they meet specific requirements.

This guide will explain how to apply for your Colorado state ID and other forms of identification.

Why do I need an ID?: Identity documents may be required to access healthcare, public benefits, housing, transportation, employment, and other essential human rights.

Having an identification card can:

- Help emergency personnel in providing emergency care.
- Provide access to basic public services.
- Promote public safety by reducing fear of interacting with law enforcement.
- Provide access to financial services.

Basic Requirements for Getting/Renewing a Colorado State ID

- Identification Document
- ITIN or Social Security Number
- Proof of Residency




All documents must be unaltered certified originals, certified amended originals, or true copies certified by the issuing agency. Photocopies, notarized documents and online printouts are not accepted.



<u>Temporarily legal residents</u> and <u>undocumented residents</u> will receive a document bearing the phrase: "Not valid for federal identification, voting, or public benefit purposes."

Sample ID:





All documents presented to the DMV at the time of your appointment must be in English or translated into English and the original should also be presented. Translators must provide the following statement at the end of the translated documents and it must be typed or electronically printed on the same page

as the translation, not on separate pieces of paper, or the translation will not be accepted by the Department.

The translator statement must state the following: "*I*, ______, affirm that the foregoing is a complete and accurate translation from (insert name foreign language) to the English language to the best of my ability. I further affirm that I am fully competent to translate from (insert name of foreign language) into the English language and that I am proficient in both languages."

In the next sections of this guide, you will find a description of the required documents needed to apply for a Colorado State ID and what to do if you are missing any of the required documents.²

i. FOR TEMPORARILY LEGAL RESIDENTS

Identification Documents - Bring ONE of the following:

- Unexpired Employment Authorization Document (I-766)
- Refugee/Asylee I-94 (with photo)
- Foreign passport with unexpired temporary I-551 stamp
- Unexpired foreign passport with U.S. visa and I-94
 - AND, if your I-94 class of admission is:
 - F: Your original, unexpired I-20A/B
 - J: Your original, unexpired DS2019
 - K: Your certified U.S. marriage certificate and I-797 Application of Adjustment of Status
 - M: Your original, unexpired I-20A/B
 - V: Your certified U.S. marriage certificate and I-797 Application for Adjustment of Status
- Documents must verify through the USCIS SAVE verification system
 - Individuals with an immigration status of B-1, B-2, WB, WT, CP, or NC are not eligible for a Colorado document.
 - Individuals with an expired USCIS document <u>may</u> be eligible for issuance if an appropriate I-797 Notice of Action is presented and verifies through SAVE.

Residential Address - Bring ONE of the following:

- First class mail with dated postmark
- Credit card statement
- Insurance policy
- Rent receipt (not handwritten)
- Phone bill
- Bank statement
- Pay stub
- Utility bill
- Lease agreement/mortgage statement
- Vehicle registration/title
- Document must show your name and current Colorado residential (not P.O. Box) address including street address, city, and state.
- Document must be dated within 1 year.

ii. FOR UNDOCUMENTED RESIDENTS

Identification Documents - Bring ONE of the following:

- Foreign passport
- Consular identification card
- Military identification document
- Colorado driver license/instruction permit/ID card (for renewal only)
- $\textcircled{\bullet}$

- Document must contain your full legal name, your date of birth, the date of issuance, the name of the country that issued the document, and a full facial photograph.

- Document must be unexpired or expired less than 10 years.



Taxpayer Identification Number <u>OR</u> Social Security Number - Bring <u>ONE</u> of the following:

 - ITIN card (not laminated)
 - Letter from the Internal Revenue Service

- For Social Security Number

Colorado Residency - Bring <u>ONE</u> of the following:

- Proof of Colorado income tax return filing for the immediately preceding year
- Ocument must contain a Department of Revenue certification stamp and signature.

- Documents demonstrating Colorado residency for:
 - Current residency
 - Residency from 1 year prior
 - Residency from 2 years prior

FOR UNDOCUMENTED RESIDENTS CONT.

Examples of documents that demonstrate Colorado residency:

- First class mail with dated postmark
- Credit card statement
- Insurance policy
- Rent receipt (not handwritten)
- Phone bill
- Bank statement
- Pay stub
- Utility bill
- Lease agreement/mortgage statement
- Vehicle registration/title
- Documents must show your name and current Colorado residential (not P.O. box) address - including street address, zip code, city, and state. Handwritten and electronic documents are not accepted for proof of residential address.

iii. FOR U.S. CITIZENS & LAWFUL PERMANENT RESIDENTS

Identification Documents - Bring ONE of the following:

- Colorado driver license/instruction permit/ID card (unexpired/expired less than 10 years)
- Unexpired U.S. passport or U.S. passport card
- Unexpired ENHANCED out-of-state driver license/ID card (Available only from MI, NY, MN, WA, VT)
- Unexpired permanent resident card (I-1551)
- Certificate of naturalization/citizenship (Issued within 20 years)

Bring ONE of the following:

- State- or county-certified U.S. birth certificate
- Consular report of birth abroad
- Certificate of naturalization/citizenship (issued 20+ years ago)
- Certified U.S. adoption order (with birth information)



AND

Bring <u>ONE</u> of the following:

- Colorado driver license/instruction permit/ID card (Expired less than 10 years)
- Out-of-state driver license/instruction permit/ID card (Expired less than 10 years)
- U.S. passport or U.S. passport card (Expired less than 10 years)
- Military ID/Common Access card (Expired less than 10 years)
- VA card (issued within 20 years)
- Bureau of Indian Affairs or Tribal ID with photo (issued within 20 years)
- Corrections ID card
- Parent or legal guardian with identity document and proof of guardianship (if under age 21)



FOR U.S. CITIZENS & LAWFUL PERMANENT RESIDENTS CONT.

Social Security Number - Bring <u>ONE</u> of the following:

- Social security card (not laminated)
- 1099 form
- W-2 form
- Pay stub

Residential Address - Bring <u>TWO</u> of the following:

- First class mail with dated postmark
- Credit card statement
- Insurance policy
- Rent receipt (not handwritten)
- Phone bill
- Bank statement
- Pay stub
- Utility bill
- Lease agreement/mortgage statement
- Vehicle registration/title
- Ocuments must show your name and current Colorado residential (not P.O. box) address - including street address, zip code, city, and state.



iv. What If I Am Missing Documents?

If you are missing any of the required documents, be sure to give yourself enough time before scheduling your DMV appointment to obtain everything you need.

If you are applying for your Social Security card for the first time, visit <u>www.ssa.gov</u> or call **1-800-772-1213** for the most accurate and up-to-date requirements. <u>*Required documents typically include*</u>:

- A Form I-551 (Lawful Permanent Resident Card, Machine Readable Immigrant Visa); **or**
- An I-766 (Employment Authorization Document, EAD, work permit); or
- An I-94 (Arrival/Departure Record) or admission stamp in the unexpired foreign passport.

Need Proof of Residency or Address?



If you are experiencing homelessness or do not have an established residential address, proof of residency documents are not required if you provide a letter, from a homeless shelter or not-for-profit organization, certifying that you are

homeless and are registered at the shelter.



Tell a shelter staff member that you need a residence letter for the DMV in order to get your ID.

The letter needs to be written on the shelter's letterhead and include

- The shelter or facility's name
- Address & telephone number
- Authorized staff signature
- Date
- The statement, "will accept delivery of mail for the customer."

Exceptions Processing



Individuals who cannot provide required documentation can request Exceptions Processing at their DMV appointment. Other documents may be accepted through Exceptions

Processing that would not be accepted through the standard process. Only specific DMV locations handle Exceptions Processing.

b. STEP 2: SCHEDULING DMV APPOINTMENT

You must schedule a DMV appointment ahead of time to apply for an SB251 Colorado ID. See **Appendix B** for a list of DMV offices currently offering SB251 services.



Call the DMV at (303) 205-2335 between 8 a.m. and 5 p.m. to schedule an appointment.



You can reach out to a community organization to get help with scheduling and preparing for a DMV appointment. **Appendix C** lists community groups that partner with the DMV to help people obtain ID cards, free of charge.

c. STEP 3: PREPARING FOR & ATTENDING DMV APPOINTMENT



During your appointment, a DMV staff member will review your documents. Review the required documents sheets to make sure you bring your Identification Documents, ITIN or Social Security Number, and Proof of Residency documents. If you are unsure which documents are best, bring everything you have and the DMV will help sort it out!

i. Fees & Vouchers

DMV Fees



For U.S. Citizens, Permanent Residents, or Individuals Who Can Demonstrate Temporary Lawful Presence in the U.S:

- Identification Card (under 60 Years Old): \$12.67
- Identification Card (over 60 Years Old): FREE
- Driver License, renewal: \$30.87
- Instruction Permit: \$18.52



For Individuals Who Are Unable to Demonstrate Lawful Presence in the U.S:

- Identification Card: \$13.00
- Driver License: \$33.00
- Instruction Permit: \$21.00

Vouchers



Some community organizations provide vouchers to cover the cost of IDs (See **Appendix D**). If possible, try to call before you visit an organization because some may have specific eligibility requirements, a limited number of vouchers, or operate only during specific times. Tell them that you are in need of a voucher to obtain your ID.

4. Getting a Consular ID³

a. Overview of Consular ID



A Consular ID card is a document that some consulates issue for citizens of their country who reside abroad. Consular ID cards are accepted by many financial institutions as a form of identification.





To obtain a Consular ID card, you will need to contact your local consulate or embassy. Some consulates allow you to apply by mail, but some require an in-person appointment at one of their offices. Consulate contacts are listed in Appendix A.



Countries have different requirements for obtaining a Consular ID. Generally, you will need to provide:

- Original and copy of a passport
- Original and copy of a national ID

- Original and copy of a birth certificate
- Proof of residence

If you are a Mexican citizen needing an ID, the Matricula Consular is a good option. You will need to make an appointment to complete an application at any Mexican consulate in the United States. The card will cost \$30.

- Proof of Nationality
- Proof of Identity
- Proof of Residence in the Consular District

3. Municipal ID Cards

Some cities have Municipal ID card programs to provide residents with photo identification in order to access certain services. Unfortunately, Denver does not currently have a Municipal ID program.

3. Shelter ID Cards

Most Denver shelters provide individuals with a photo ID access card, known as a Clarity Card, upon intake. You will need your access card each time you visit a shelter to receive services. There are no special requirements, nor proof of identification necessary to register.
